## Legislation gives police latitude to keep streets safe

SACRAMENTO, CA: Legislation sponsored by Assemblymember Bob Huff to give police officers authority to prevent unsafe drivers from operating their vehicles passed out of the State Assembly by a vote of 53-14.

"If an officer decides a driver poses a danger to others on the road, it defies common sense to let them get back in their car, put the keys in the ignition and drive away," said Assemblyman Huff.

Currently, when a police officer encounters a driver incapacitated for reasons not related to drugs or alcohol, the officer may issue the driver a Notice of Priority Re-Examination. This test is conducted

by the Department of Motor Vehicles. Because there is no authority to separate a driver from the vehicle, most drivers are released and continue to operate their ve-

hicle, even though they present a significant risk to the public.

Supported by the California

Highway Patrol, AB 226 would allow a peace officer to separate an individual from their vehicle after being issued a Priority Re-Examination - but only as a last resort. If another driver in good standing is available, the officer can release the automobile to that person.

"The intent is not to seize vehicles from drivers," continued Assemblyman Huff. "Instead, this bill will help ensure public safety on our roads by giving officers the option of taking the vehicle until the driver has been approved by the DMV."

AB 226 will be heard next in the Senate Transportation Committee.

Assemblyman Huff is Republican Caucus Chairman and represents portions of Los Angeles, Orange and San Bernardino counties.
